REQUEST FOR PROPOSAL STRIP MALL FEASIBILITY STUDY

Wahnapitae First Nation is seeking qualified firms or consultants to conduct a feasibility study for the development of a **strip mall** at the First Nation. This study will assess the market demand, financial viability, site suitability, and other critical factors necessary for the successful planning and development of the strip mall.

The proposed strip mall will be located on the First Nation. This project envisions the development of a retail center with multiple units designed to house local businesses, service providers, and external tenants that will offer a range of services to both the local community and visitors.

Scope of Work
